Conditions & Information for all Participating Artists

Exhibit Display Dates: (February – July 2018)

Work must be displayed for entire exhibit period. Artist will be responsible for replenishing any items sold. If unsold items are removed at Artists request before conclusion of exhibit, Artist will be invoiced \$10 Removal Fee per item.

Installation Date(s): (February 1, 2018) - **Removal Date(s):** (August 1, 2018)

Artwork must be original work by the artist, completed within the last 5 years not under academic supervision. Reproductions or craft kits are not accepted. Artist must be 18 years of age or older.

Gallery Space: Individual artists will be assigned a gallery wall panel (approximately 14 ft. high by 20 ft. wide) to fill with their work (1–8 items), thus pieces should be large enough to adequately fill that space. Take into consideration that wall lights are attached on each panel. All works must be two dimensional, framed or gallery-wrapped canvases (with all sides painted), and ready to hang with wire on the back. No sawtooth hangers are allowed. Non-glare glass is recommended for any framed photography. Descriptive tags with item information and price will be created and attached to lower right edge using non-destructive artist tack at the discretion of the BRAC Art Gallery Committee.

Insurance is the responsibility of the artist. The Branson Convention Center does not accept responsibility of theft, vandalism or damage caused by gallery patrons or staff, or caused during transfer for any reason including mishandling by carrier or failure of packaging to protect works in transit. Also not covered, is damage cause to work by failure of the work itself, or its mounting systems installed by the artist.

Commissions: All displayed work must be for sale. The Branson Regional Arts Council will promote, sell, and deliver all displayed items for consignment sale on behalf of artist, and retain a 20% commission on any item sold. Applicable Sales Tax and Shipping Fees will be paid by the purchaser. Artist will receive commission check within 2 weeks of receipt of funds from purchaser. Artist agrees that, for a period of sixty days following the end of the exhibition, any commission resulting from the display of work at the Convention Center or through a referral by the Convention Center will entitle Branson Regional Arts Council to a 20% referral commission.

Agreement: I attest that the art submitted is my original work. Descriptions of the works in the above or attached list are accurate. I understand that my participation and signature below constitute acceptance of all conditions to this prospectus, including the right of Branson Regional Arts Council to use digital images and information about entries for publicity, promotion and online sales.
